PARENTAL/GUARDIAN PERMISSION AND EQUIPMENT CHARGE I/we, the parent(s)/guardian(s) of the above named participant, hereby give my/our approval for participation in any and all of the activities of the Ridgeview Mustangs JFL during the current season. I/we assume all risks and hazards incidental to the conduct of any of the activities, including transportation to and from such activities. I/we do further release, absolve, indemnify and hold harmless Ridgeview Mustangs JFL, its organizers, sponsors, directors, and supervisors, any or all of them. In case of injury to my/our child, I/we hereby waive all claims against the organizers, sponsors, directors, or any of the supervisors appointed by them. I/we likewise waive, to the extent not covered by liability insurance, any claim against any persons transporting my/our child to or from activities. I/we assume full cost of all issued equipment if not returned, altered, lost, or from negligent damage.

EMERGENCY MEDICAL AUTHORIZATION I/we, the parent(s)/guardian(s) of the above named participant, hereby give my/our authorization for any emergency medical treatment of the participant for any injury resulting from any activity of Ridgeview Mustangs JFL. It is understood that efforts shall be made to contact the undersigned prior to rendering treatment to the injured participant. This authorization shall expire on November 1 of the year this application is signed.

REGISTRATION FEES Football Players: Registration fee is **\$100. Flag Football: \$50 Cheerleaders: \$75.** Registration forms received **AFTER 6/01** will require an additional **\$20 LATE FEE.** Families with multiple participants in the Tackle Football program will receive a discount for each additional child as follows: **\$50 2nd child, and \$25 for 3rd and each additional child(ren).** **ALL participants MUST** furnish a copy of their birth certificate and sports physical **BEFORE** the first practice to participate. Make checks payable to "**Ridgeview JFL**". A \$25 fee will be charged for all returned checks.

IN CONSIDERATION OF my child/ward, being allowed to participate in any way in the Ridgeview Mustangs Junior Football Team related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury to my child/ward from the activities involved in the programs is significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. FOR MYSELF, SPOUSE, AND CHILD/WARD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for child/ward, participation; and,

3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe an unusual significant concern in my child/ward's readiness or, hazard during my presence or participation, and/or in the program itself, I will remove my, child/ward, from participation and bring such to the attention of the nearest coach or official immediately; and,

4. I, for myself, my spouse, my child/ward, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS RIDGEVIEW MUSTANGS JUNIOR FOOTBALL LEAGUE; their officers, directors, officials, volunteers, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, incident to my child/ward's, involvement or participation in these programs, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW.

5. I, for myself, my spouse, my child/ward, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS all the above Releasees from any and all liabilities incident to my child/ward's involvement or participation in these programs, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent permitted by law.
